1 — PARTIES & SCOPE

This License Agreement is between M. Janee Photography, LLC / Noir Label Stock ('Licensor') and the individual licensee indicated at the time of download or account creation ('Licensee'). This is an individual, single-user license for non-commercial personal use only.

If multiple individuals will use the same Licensed Asset, each must obtain a separate license. For any commercial use, a Commercial or Extended Commercial License is required.

2 — DEFINITIONS

2.1 — Licensed Asset

Any AI-generated image, graphic, or visual file downloaded from noirlabel.photos under this license.

2.2 — Non-Commercial (Personal) Use

Use solely for personal, non-monetized purposes. Any use that involves an exchange of money, promotes a business, product, or service, or where financial gain is sought or results — directly or indirectly — is Commercial use and is not permitted under this license.

- ✗ Use to train, fine-tune, or augment any AI or machine learning model.

5 — STRICTLY PROHIBITED USES
